#### Please note the following:

- Session 2025–26 will start on 21.07.2025.
- Fee is payable into Kothari International School, Kharadi Pune
- Due on or before the 10th day of every quarter (10th July, 10th October, 10th January, 10th April).
- Security money is refundable at the time of withdrawal of the student from school (Parents are required to provide their bank account details for re-transfer of the amount payable to them).
- Current month fees along with one month notice period is to be charged in case of withdrawal of student from school.
- · Admission fee is not prorated or refundable/adjustable.
- Late Fee ₹100/- per day will be charged from due date of fee.

#### Items covered:

Composite fee covers the cost of providing Education to the child. Fees are charged separately which covers the additional academic and co-curricular activities; value added programmes, certain stationery etc. Other expenses incurred by costumes, certain books/journals/and stationery shall be paid as extra by the concerned students. Damage or loss of school property by the student also shall be paid as an extra charge.
